Dear UNM Speech and Hearing Department,

I am writing to express my strong interest in the clinical instructor position at the UNM Speech and Hearing Department, which I learned about through Sarah Duncan. The opportunity to join your esteemed institution in a role that combines my extensive experience in Speech-Language Pathology (SLP) with my passion for mentorship is truly exciting.

Throughout my career there has been a motif, new opportunities. I've been all over the country working with in a variety settings with a diverse patient populations, their families, and hard working, brilliant colleagues. This job at UNM would also be a new opportunity for me which I would love to embark on.

I've been a practicing SLP for the last sixteen years. I initially came to New Mexico prior to starting graduate school. I lived in Taos, NM and worked as an educator on the Taos Pueblo. It left a lasting impression on me and I knew I would be back someday.

I completed my masters degree at San Francisco State
University in 2007 which led me into my first job working in
Texas with TBI patients at a post acute long term setting. I
was ready for this new opportunity to have better hands
on experience with TBI patients. I remember making
strong connections in this setting with patients and being
able to utilize tools such as The Ranchos Los Amigo Scale.
This was one of the first tools that I learned about and
used professionally that I left a lasting impression on me. It
was one of the first opportunities where I used a
diagnostic tool and watched my patients move within that
scale. It was fascinating and challenging.

After several years of working exclusively in TBI, I moved into acute care where I have spent the last thirteen years. The hospital setting was so important to me because I craved more medical knowledge and experience. Studying neurology wasn't enough for me. After working with TBI

patients for three years I wanted to improve and understand the variety of medical conditions and the SLP's role in acute care. It was another brand new opportunity that shaped me into the clinician I am now. In that time, I helped build our team at Seton Medical Center, started a journal club, spoke at nursing and unit meetings, and was a practicum site for University of Texas Austin graduate students.

I would love another opportunity to mentor and guide students not only through assisting with identifying sites, but also helping guide students through that time in the field. I remember fondly a professor in graduate school who always tied in excellent examples to help us understand what we were learning. There is nothing more powerful than laughing at medical stories to help bring context to new learning. I want to provide real examples and stories to students to help improve their learning and understanding.

During 2020, I was at a Level 1 Trauma Center in southwest Virginia. It was an incredibly challenging two years. I helped develop and implement our first COVID safe protocols for SLP's and was one of the first SLPs that covered our COVID floors.

After those two years, I was ready for a new opportunity and came back to Taos where I worked in Home Health for the last two years. The community in northern NM is unique and diverse and one of my most favorite places Ive worked. I had the pleasure of working with people across the wide variety of socioeconomic status and location, some with no running water or electricity.

I moved to Albuquerque in May 2023 and I am currently working as a Therapy Coordinator and SLP in an outpatient setting. In this role I have continued to build my leadership and communication skills running this clinic.

This is the first university job I've ever applied to and I would love to have this be another new opportunity not only to learn more, but give back to students to help them grow and develop their skills.
